Sheriff Fred E. Erickson, 34. died suddenly and unexpectedly at his home during the noon hour to-day.

He left his office at twelve o'clock with his deputy, Elmer Zinn, and at that time was feeling about as well as usual. Erickson told Zinn as they were leaving the courthouse that he planned to go to Spirit Lak? this afternoon and not to expect him in the office this afternoon.

The sheriff had served this county in that office for 18 years and had just been re-elected to another term. The high esteem in which he was held throughout the county is indicated by the fact

that in nearly every election he received the most votes of any man in the courthouse.

Funeral arrangements are being made through the Cobb-Warner Funeral Home but are not complete at this early hour.

Suffered Attack

Erickson had suffered a severa heart attack early in the summer and was in the hospital three weeks at which time he was able to be returned to his home. When he was again able to travel, he and Mrs. Erickson went on a trip north mainly as a trip of relaxation and rest for the sheriff. It took him away from the strains and responsibilities of his office which he could not escape while in Spencer, for his home was on the first floor of the jail building.

His doctors advised rest and complete giving up of active exercise which eliminated golf and bowling for him, two sports which held his enthusiasm.

He is survived by his widow and their two adopted children, Tonymy and Lynn who came to make their home here only a few months ago.
